Special Conditions:

- (3) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (5) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (6) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (7) Operations in the following frequency bands are prohibited:
406.00-406.10 MHz,
412.925-412.950 MHz,
413.100-413.125 MHz,
413.5875-413.6125 MHz,
414.9875-415.0125 MHz.
- (8) Operation is subject to notification of Location & Monitoring Service licensees (902-928 MHz) within 50 miles of the test area.
