- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) This authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (5) The fixed and mobile stations antenna main beam elevation angle is at (zero degree) or below the horizon (below zero degrees).
- (6) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (7) Operation is subject to prior coordination with the Fixed Microwave Service licensees around each test site in accordance with 47 C.F.R, Part 101.103(d).
