Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

  - e. 2259 MHz +/- 5 MHz
  - f. 2269 MHz +/- 5 MHz
  - g. 2279 MHz +/- 5 MHz
- (3) Due to the existing Federal operations in the Phoenix area, CP Communications must restrict use to the stadium and adjacent areas
