NAME CP Communications

This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Special Conditions:

- (1) This frequency assignment in one of the bands 1435-1535 or 2310-2390 MHz was coordinated prior to authorization with the Mid-Atlantic Area Frequency Coordinator (AFC), Patuxent River, MD, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the AFC as necessary to ensure compatibility with existing uses.
- (2) This frequency assignment in one of the bands 1435-1525, and 2360-2390 MHz was coordinated prior to authorization with the Air Force Spectrum Management Office, Fort Meade, MD, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the Air Force Spectrum Management Office, Fort Meade, MD, as necessary to ensure compatibility with existing uses.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) For frequency assignment(s) in the bands 2360-2395 MHz, CP Communications must coordinate prior to authorization with the DoD AFMO-US&P AFC (Area Frequency Coordinator) who also coordinates, as appropriate, with Aerospace and Flight Test Radio Coordinating Council. Use of these frequencies under the authority is subject to such further coordination with the AFC to ensure compatibility with existing users.
- (6) Operations are on a non-interference basis to Flight Test telemetry and Air Force Spectrum Dependent System.

Special Conditions:

- (7) Non-interference basis to all Flight Test telemetry missions and no protection afforded to CP Communications LLC operations.
- (8) Unprotected NIB operations are under an MO station class.
- (9) STOP BUZZER POC provided with cell and land line contact information that can cease any and all CP Communications LLC emissions if EMI is detected. Please reference FCC STA 1588-EX-ST-2021 and this AFTRCC ICN 1472-21/8933 coordination when notifying the MIDLANTAFC office of STOP BUZZER POC info.
