Special Conditions:

- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) The designated point-of-contact to terminate transmissions if interference occurs is Mr. Irwin Morse at (321) 541-1285.
- (5) The application is not intended to cover 50 units of the same type. Instead, the application seeks authorization for 13 different models. There will only be a maximum of 10 units of each model type tested at one time.
- (6) Operations on the following frequency band are denied: 150.8-173.4 MHz.
