Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The radars mounted on UAS shall not be used for air traffic control purposes or separation of aircraft.
- (4) Aircraft operations are limited to U.S.-registered aircraft.
- (5) The authorized station must be in compliance with the Federal Aviation Administration (FAA) requirements as set forth in Section 17.4 of the Commission's Rules.
- (6) The authorized station must be in compliance with environmental requirement set forth in Section 1.1307 of the Commission's Rules.
- (7) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (8) This authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.

- (10) Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.
- (11) No automatic renewal for this authorization.
- (12) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by DARPA, contract number HR0011-17-9-0017. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not operate after the expiration date of the contract designated in the related application and enumerated above.
