- (5) Coordination with the YUMA Spectrum Management Office is mandatory at least 14 calendar days prior to any intended use of this frequency on YPG or within its restricted airspace by contacting the YPG SMO at 928-328-7144.
- (6) Operations must be scheduled as a WSMR range mission, through the WSMR range sponsor. Final authority to radiate is contingent upon successful scheduling and de-confliction of spectrum, with other area operations. Per clearance-prior to activation, the applicant must coordinate with WSMR Frequency Control at 575-678-1193.
- (7) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by DARPA Mobile Force Protection, Contract Number HR0011-17-9-0017. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
