- (6) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (7) The authorized station must be in compliance with environmental requirement set forth in Section 1.1307 of the Commission's Rules.
- (8) The authorized station must be in compliance with the Federal Aviation Administration (FAA) requirements as set forth in Section 17.4 of the Commission's Rules.
- (9) This authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (10) Experimental station shall use the minimum power level necessary to close the communications link to minimize potential interference to licensed users.
