- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Operations on 1375 MHz, 3000 MHz, 14000 MHz and 35000 MHz require scheduling with the Western Area Frequency Coordinator at 805-989-1003.
- (4) Licensee shall avoid interference to licensed operations on 40.53 MHz.
- (5) Licensee shall exclude operations on frequencies between 74.6-75.4 MHz.
