In Application of: EMG USA, LLC.

To Operate in the 2250 - 2270 MHz and 3350-3370MHz Telemetry Band to Provide TV Coverage in Frisco, Tx.

ATTN.: Microwave Branch

EMG USA hereby requests Special Temporary Authority (STA) to operate in the 2250-2270MHz and 3350-3370 MHz Telemetry Band pursuant to Section 21.25 of the Commission's Rules. EMG USA requests that the Commission grant temporary authority to operate on two 10 MHz wide channels centered at 2255 MHz and 2265 MHz and two 10 MHz wide channels centered at 3355 and 3365 MHz with a 10MHz bandwidth on July 14, 2026 with intermittent usage. Please note EMG is fully capable of working 2200-2300MHz and 3300-3400MHz. EMG can work within these parameters and if needed can move and adjust.

As explained below, EMG USA is filing an STA request for the Live Television Transmission Men in Blazer's coverage of USA Match Day event. EMG USA submits that there are extraordinary circumstances warranting a grant of the STA request. Men In Blazers has contracted EMG USA to provide the necessary microwave for the Live Transmission of this event. Due to the extreme frequency congestion in Frisco, Tx, coupled with the added congestion from traditional television and news coverage of these special events, EMG USA requests the use of channels in the 2250-2700 MHz and 3350-3370 MHz telemetry band. EMG USA certifies that the operation of the requested channels for the purposes specified herein will not cause interference to any established stations.

Grant of the instant request for STA in the 2250-2270 MHz and 3350-3370 MHz Band would serve the public interest by enabling EMG USA to supply the requested remote video coverage for this event. The proposed service would enhance coverage of the event by providing on the spot pictures from mobile locations that would not otherwise be available to the Production Company.
