Dear Mr. Ekstrom:

Comsearch has completed the frequency coordination for Ericsson's temporary PCS operations in Plano, TX, for the time period starting from April 15, 2001 through April 30, 2001. The specific frequencies coordinated are listed on the attachment.

In order to avoid harmful interference with microwave systems and to comply with the FCC rules and regulations, we have analyzed the temporary operation using Comsearch's spectrum management tools against other microwave systems within the FCC required coordination distance. The calculations used in our analysis follow the guidelines specified in TIA Telecommunications Systems Bulletin (TSB) 10-F, "Interference Criteria for Microwave Systems." Specifically, it includes both threshold degradation and carrier-to-interference (C/I) methodologies for analog and video microwave receivers, and threshold-to-interference (T/I) methods for digital microwave receivers. Industry accepted propagation models are used in order to compute the interfering levels into microwave receivers.
