- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) Operation on the frequency 1245 MHz is limited to within 200 miles of the coordinates above. On this frequency, 1245 MHz, the aircraft is limited to an antenna radiation pattern that is directly toward the ground, directly below the aircraft and does not exceed a 3 degree beamwidth.

Special Conditions:

- (3) Operation on the frequency 1255 MHz is limited to within 200 miles of the coordinates above and ONLY within the azimuths from 320 degrees to 90 degrees (north quadrant) reference to true north. On this frequency, 1255 MHz, the aircraft is limited to an antenna radiation pattern that is directly toward the ground, directly below the aircraft and does not exceed a 3 degree beamwidth.
- (4) Operation on the frequency 1270 MHz is not permitted until the aircraft is at least 25 miles out from the coordinates above and only to a maximum range of 200 miles from the coordinates. Additionally, operation on 1270 MHz is ONLY permitted within the azimuths from 140 degrees to 205 degrees (south quadrant) reference to true north. The aircraft is limited to an antenna radiation pattern that is directly toward the ground, directly below the aircraft and does not exceed a 3 degree beamwidth.
