This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Purpose Of Operation:

Demonstrate that the radio system operating in the 2.2GHz band can robustly provide the required bandwidth facilitating operations of an autonomous surface vessel operating in a stream

Special Conditions:

- (1) The occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Exxon Communications Company must submit the stop buzzer name, phone number, and email to the DHS spectrum office prior to operations, Mr. Jason Chabot, jason.chabot@hq.dhs.gov and agrees to immediate cease operations at the request of the Department for any reason.
- (4) Exxon Communications Company should be aware should be aware that the band 2200-2290 MHz is allocated for federal operations and is an extremely congested band. Non-federal use is on a case-by-case basis.
