Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee must successfully coordinate with the local Society of Broadcast Engineer frequency coordinator prior to operation on 170.125 MHz, 170.55 MHz, 171.25 MHz, 172.375 MHz, 172.55 MHz, 453.125 MHz, 453.7 MHz, 455.05 MHz, 455.425 MHz, and 470.55 MHz.
- (4) Licensee must "notification" of the Paging Service licensees in 454 MHz/459 MHz within 50 miles of the test area.
