Special Conditions:

- (3) The following frequencies are to be notched out: 225.4, 229.4 and 233.7 MHz. The frequency 228.8 MHz shall not be used in AREA 2. The frequency 228.45 MHz shall not be used in AREA 6.
- (4) Operations in the 222-234 MHz band shall be used only for the testing of equipment for export and is subject to the understanding that there is no intended operational use of this equipment within the Commonwealth of Puerto Rico nor the Territories and Possessions of the United States of America.
- (5) Operations near the band 216.88-217.08 MHz are subject to immediate adjustment including cessation if interference is caused to the United States Navy SPASUR operations. Coordination is required with Commander, Naval Space Command, Dahlgren, VA 22448, Telephone 540-653-6190.
- (6) Operations near the band 217.08-221.52 MHz are subject to immediate adjustment including cessation if interference is caused to the United States Navy SPASUR operations. Coordination is required with Commander, Naval Space Command, Dahlgren, VA 22448, Telephone 540-653-6190 when operations are within 150 miles radius of
