- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Prior to operation, the licensee of this authorization must successfully coordinate with the existing and future 71-76 GHz and 81-86 GHz users.

Special Conditions:

- (4) The licensee must successfully coordinate with the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d) prior to operation in 10.7-11.2 GHz, 11.5-12 GHz, 12.7-12.75 GHz bands.
- (5) Operation is subject to prior coordinate with the local Society of Broadcast Engineer frequency coordinator and the Fixed Microwave Service licensees prior to operation in 2400-2484 MHz band and 12.7-12.75 MHz bands.

- (7) While the FAA acknowledges that no UAV will be used in this testing, the proponent must know that the unlicensed spectrum being used for future UAV development (902-928 MHz, 2400-2484 MHz, UNI-I bands) are not considered viable for operation above 400 feet.
- (8) Transportation concurs but requests the user be aware that out of band emissions (OOBE) into the band 5850-5925 MHz may prove problematic in the future due to use for safety services in Transportation.
- (9) Testing operations in the frequency band 12.2-12.7 GHz are prohibited.
- (10) Prior to operation, licensee must notify the potentially-affected earth station operators that are located within a 30 mile radius of the experimental transmitter and obtain their written consent to the proposed operations.
- (11) Ensure that the transmitting antenna(s) main beam do not point above the horizon in order to protect satellite space stations operating in overlapping frequency bands.
- (12) This license SUPERSEDES the previous issued license with the same call sign and file number: amends the special conditions.
