- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) FCL Tech, Inc. must obtain consents from the Advance Wireless Service licensees prior to accessing to 1710-1785 MHz band.
- (4) Operation is subject to prior coordination with the local Society of Broadcast Engineers frequency coordinator and the Fixed Microwave Service licensees prior to operation in 935-960 MHz band.
- (5) FCL Tech, Inc. must notch out 1830-1845 MHz due to potential interference with ongoing law enforcement operations.
- (6) FCL Tech, Inc. must notch out 1756.5 MHz and 1880 MHz.
- (7) Prior to commencing any operations in the frequencies below, the applicant must obtain consent from the following within 50 miles of the contours of the testing area:
 - Cellular licensees (824-849 MHz/869-894 MHz)
 - Commercial Air-Ground licensee (849-851 MHz/894-896 MHz)
 - SMR licensees (896-901 MHz/935-940 MHz)
 - B/ILT licensees (896-901 MHz/935-940 MHz)
 - Narrowband PCS licensees (901-902/930-931/940-941 MHz)
 - Location & Monitoring Service licensees (902-928 MHz)
 - Broadband PCS licensees (1850-1910 MHz/1930-1990 MHz)
