The notification should include the testing parameters (specific location(s), antenna gain(s), antenna height(s), antenna orientation, EIRP, EIRP density) and day and times of each test.
- (8) Operation is NOT PERMITTED using the frequency band 757-809 MHz, 851-854 MHz, 1780-1845 MHz and 2025-2110 MHz.
- (9) The use of phone jammer, GPS blocker or other signal jamming devices designated to intentionally block, jam, or interfere with licensed or authorized radio communications is prohibited.
- (10) Stop Buzzer, Dave Peterson at (703) 474-2313.
- (11) Fenix Group, Inc must obtain consents from the Educational Broadband Service and Broadband Radio Service licensees prior to accessing to the frequency range from 2500 MHz to 2690 MHz.
- (12) Fenix Group must coordinate with the local Society of Broadcast Engineer frequency coordinator prior to operation.
- (13) Prior to activation, the applicant must coordination with the Area Frequency Coordinator located at White Sands Missile Range, New Mexico, prior to use in the State of New Mexico and other US Territory within a 240-kilometer radius of WSMR plus the area of Utah and Colorado that lies South of 41 North and between 108 and 111 West.
- (14) Operation must be scheduled as a WSMR Range mission through the WSMR Range sponsor. Final authority to radiate will be contingent upon successful scheduling and de-confliction of both airspace and spectrum with other area operations by the WSMR ISM who reserves the right to impose additional restrictions.
