remote user terminals;⁴ and (iii) a groundstation in Logan, Utah.⁵ The authorizations for these components will expire on August 1, 1999. Grant of these renewal applications is in the public interest and consistent with the Commission's rules, for the reasons explained in the attached applications. Accordingly, Final Analysis respectfully requests the Commission expeditiously to grant the enclosed applications for renewal of the above-captioned authorizations for a two-year period.⁶
