- (5) Prior to equipment authorization or a determination of compliance, the device must be accompanied by a conspicuous notice worded as follows: "This device has not been authorized as required by the rules of the Federal Communications Commission. This device is not, and may not be, offered for sale or lease, or sold or leased, until authorization is obtained."
- (6) Operation in the 2155-2165 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of Multipoint Distribution Service licensee(s) to avoid interference.
- (7) Operation in the Wireless Communications Services (WCS) bands requires consent of WCS licensee(s) to avoid interference.
