This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

- (6) No automatic renewal for this authorization.
- (7) The authorized herein must not be used for air traffic control communications.
- (8) Fortem Technologies, Inc. should be aware that the 15.4-15.7 GHz shall be used only for Detect and Avoid operations. Counter UAS operations are not permitted.
- (9) Fortem Technologies, Inc. should also be aware that radio astronomy services (RAS) has a primary band from 15.35-15.4 GHz where all emissions are prohibited. Any future operational use or development that may cause interference to this band would not be supported. - (10) NTIA notes adjacent band 15.35–15.4 GHz which is protected IAW US246. Future use at other locations near those listed in US131, may be problematic if emissions are allowed to cross into the band 15.35-15.4 GHz.
