This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Temporary Authority is hereby granted to operate the apparatus described below:

Special Conditions:

- (3) For operations in the 15.43-15.63 GHz, the effective EIRP must be in accordance with recommendation ITU-R S.1340.
- (4) The stop buzzer contact for this project is Jeffery Davis at 801-822-8043.
- (5) The authorized herein must not be used for air traffic control communications.
- (6) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (7) This authorization is without prejudice to any determination that the Commission may make regarding pending or future experimental satellite earth station applications.
- (8) Future STA requests to extend this authorization will not be considered.
- (9) This experimental station shall only be used for Detect and Avoid (DAA) operations. It shall not be used for radiolocation purposes such as UAS detection for security perimeters, drone interdiction or counter-UAS purposes.
- (10) Fortem Technologies, Inc. should be aware that the adjacent band 15.35-15.4 GHz which is protected IAW US246. Future use at locations near those listed in US131 may not be able to be supported
