This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (3) No WiMAX equipment in the band 3300-3650 MHz will be offered for U.S. sales.
- (4) Licensee shall coordinate at least 24 hours in advance with DOD Western Area Frequency Coordinator at Pt. Mugu, CA (805-989-7983) to avoid interference.
