Special Conditions:

- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Coordination with the YUMA Spectrum Management Office is mandatory at least 14 calendar days prior to any intended use of this frequency on YPG or within its restricted airspace by contacting the YPG SMO at 928-328-7144. FAA conditionally concurs with the use of this spectrum for the support of legacy military UAS C2 Systems, but it shall not be used for development of new military or any civilian UAS platforms. Instead, it may be used for the transition of existing platforms to the 5030-5091 MHz range. Also, the flight operations shall be limited to restricted airspace R-2306, R-2307, R-2308, and R-2311.
- (5) This FCC license in accordance with FCC Part 5 rules is for the use of radio systems for experimental aviation purposes. The operation of Unmanned Aircraft Systems must comply with all applicable parts of 14 CFR including, but not limited to, parts 21, 45, 47, 61, and 91 and any other appropriate government oversight agency requirements.
