Purpose: This authority will permit the operation of ultra-wideband laboratory test equipment for the purpose of evaluating the functionality of the UWB technology being developed by Time Domain Corporation.

Testing conducted under this authority will be focused on the evaluation of indoor UWB propagation characteristics. Our testing at the site listed above and over the time period specified above, will involve only indoor propagation.

Number of units: Two (2) PADs

Antenna gain: Nominally 0 dB

Radiated power: less than – 71.25 dBW/MHz per device

Note: The radiated emissions level will not exceed the limits that would apply to an “unintentional” radiator under the general Part 15 limits set forth in Section 15.109 of the Commission’s Rules.

The Commission has heretofore found it to be in the public interest to explore the development of ultra-wideband technology. *See Notice of Inquiry* in ET Docket 98-153 released September 1, 1998 and *Notice of Proposed Rulemaking*, released May 11, 2000.
