- (7) In the 410 - 420 MHz band, Gore Design Completions is authorized to use the following single channel:
 - a. 415 MHz
- (8) Gore Design Completions must notch out the following in the 420 - 495 MHz band +/- 3.25 MHz
 - a. 425.75 MHz
 - b. 428.75 MHz
 - c. 431.75 MHz
 - d. 434.75 MHz
 - e. 437.75 MHz
 - f. 440.75 MHz
 - g. 443.75 MHz
 - h. 446.75 MHz
 - i. 467.80 MHz
- (9) Gore Design Completions must notch out the following in the 1710 - 1999 MHz band:
 - a. 1755 - 1850 MHz band
- (10) Gore Design Completions must notch out the following in the 5600 - 5900 MHz band:
 - a. 5600 - 5650 MHz band
- (11) Operation in the 1915-1920 MHz, 1995-2000 MHz or 2010-2025 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (12) Operation in the 700 MHz "C" Block requires consent of Verizon.

Special Conditions:

- (13) Operation requires notification of Paging licensees and General Aviation Air-Ground licensees in 454 MHz and 459 MHz, Commercial Air-Ground licensee, Gogo (849-851 MHz, 894-896 MHz) and Narrowband PCS licensees (901-902 MHz).
