- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (2) Authorization granted for experimental operations to and from base station facilities that will be deployed on currently existing antenna structures. This authorization is conditioned upon GTCS's subsequent completion of all environmental review processes for these antenna structures that were required under Part 1, Subpart I of the Commission's rules to have been completed before these antenna structures were constructed. Authorization is granted in order that CN may test the operation of its Positive Train Control system in compliance with Federal Railroad Administration regulations. The application remains pending with respect to transmissions involving base station facilities on antenna structures that have not yet been constructed.
- (3) Authorization granted with respect to the remaining base station facilities that require construction of new antenna structures. This authorization is conditioned upon GTCS's subsequent completion of all environmental review processes for these antenna structures that were required under Part 1, Subpart I of the Commission's rules to have been completed before these antenna structures were constructed. Authorization is granted in order that CN may test the operation of its Positive Train Control system in compliance with Federal Railroad Administration regulations.
- (4) This license SUPERSEDES the previously issued license with the same call sign and file number: adds Special Condition (3).
