- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) GXM Consulting LLC, must coordinate operations, with the Fort Bliss/McGregor Range Army Installation, with Mr. Andy VanAmburg, PdM NETMOD, andrew.m.vanamburg.civ@mail.mil, and/or Mr. Aaron Brown, SIGMOD Support, 706-570-0973, aaron.d.brown.ctr@mail.mil, to obtain the necessary support. Mr. Brown, the local sponsor, will then coordinate with the Acting Fort Bliss Spectrum Manager, SFC Jonathon Kruskamp, to schedule and de-conflict the necessary spectrum.
- (4) Licensee shall secure consents from the Educational Broadband Service and the Broadband Radio Service licensees prior to operation in 2551.5-2568 MHz and 2673.5-2690 MHz bands.
