- (4) GXM Consulting LLC must coordinate operations in the 2673.5-2690 MHz frequency band with the Electromagnetic Spectrum Management Unit, Division of Astronomical Sciences, National Science Foundation, Room 1030, 4201 Wilson Blvd., Arlington, VA 22230, in advance of operation.
