- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) The occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee shall secure consents from the Educational Broadband Service and the Broadband Radio Service licensees prior to operation in 2551.5-2568 MHz and 2673.5-2690 MHz bands.
- (4) GXM Consulting LLC. must coordinate operations must be coordinated with the Fort Bliss Spectrum Manager at 915-741-0780, and with the Pre-Mobilization Exercise and Training (PMET) office at 915-568-2191 or 915-569-6118. Final authority to radiate is contingent upon successful scheduling and de-confliction of both airspace and spectrum with other area operations by the Fort Bliss Spectrum Manager who reserves the right to impose additional constraints.
- (5) GXM Consulting LLC. must coordinate operations in the 2673.5-2690 MHz frequency band with the Electromagnetic Spectrum Management Unit, Division of Astronomical Sciences, National Science Foundation, Room 1030, 4201 Wilson Blvd., Arlington, VA 22230, in advance of operation.
