Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee shall secure consents from the Educational Broadband Service and the Broadband Radio Service licensees prior to operation in 2551.5-2568 MHz and 2673.5-2690 MHz bands.
- (4) GXM Consulting, LLC shall restrict operations to prevent any emissions from extending above 2690 MHz into the 2690-2700 MHz frequency band.
