Transmitted herewith on behalf of the Harris Corporation ("Harris") is its FCC Form 442 Application for Renewal and Modification of Experimental Station KF2XEW, Rochester, NY. An original and two copies of this application are submitted along with the requisite filing fee of \$45.00.

In addition to renewal of these stations, Harris seeks to add twelve additional frequencies which will allow it to continuing operating its experiments in situations where other companies are also operating on some of the licensed frequencies. The requested frequencies are set out in Exhibit 1. Should these frequencies be unavailable, in whole or in part, Harris requests that the Commission add to the license twelve additional frequencies at the low end of station's spectrum band, 4635 KHz - 15,492.5 KHz.
