Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (4) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (5) Authorized power and emission shall be as authorized in Parts 21, 22, 74, 78 and 101 of the Commission's Rules.
- (6) Licensee is required to coordinate operations with existing microwave users in the area to avoid interference.
- (7) Coordination with the U.S. government is required for any operations in 17.8-19.7 GHz band within any of the quiet zones listed in 47CFR1.924(e).
- (8) Operations in 21.2-23.6 GHz must be coordinated with NTIA and the Western Area Frequency Coordinator (WAFC), (760) 939-6948, prior to activation.
