Special Conditions:

- (2) Licensee project is limited to proof of concept demonstrations and testing and will not involve live-duty operations to protect life, property, or safety.
- (3) Licensee must accept interference from any other user of Band 14 and all operations by Licensee will be on a secondary basis.
- (4) Licensee must verify that there is no current potential for interference with FirstNet operations or those approved to operate in Band 14 per license (i.e., any Band 14 incumbents).
- (5) POC must be established and sent to FirstNet upon STA approval with "kill switch" authority; Licensee agrees to cease operations at request of FirstNet immediately upon receipt of request to kill switch POC until such time, as determined by FirstNet, that project may continue.
- (6) Licensee agrees that FirstNet has the right to monitor its operations.
