- (3) Operation will occur no longer than the period between August 16, 2013 and August 23, 2013, allowing time during that period for setup and testing, demonstrations, and teardown.
- (4) This Experimental STA is non-renewable. Any Experimental STA use of radio frequencies licensed to FirstNet beyond the period of August 16, 2013 and August 23, 2013 must be made by a separate request.
- (5) Harris understands that the requested experimental authority only permits shared use of radio frequencies and they may have to coordinate with other conference attendees using radio frequencies. It is possible that FirstNet may issue similar concurrences to other applicants attending the conference.
