Special Conditions:

- (3) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (4) Operation in the 1910-1930 MHz band requires coordination with UTAM, Inc. pursuant to Section 15.307 of the Commission's Rules.
- (5) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (6) Authorized power and emission shall be as authorized in Parts 21, 22, 74, 78 and 101 of the Commission's Rules.
- (7) Licensee is required to coordinate operations with existing microwave users in the area to avoid interference.
