My colleague David Alianti and I are supporting the Department of Defense (DoD) Chief Information Office (CIO) to assist in the coordination of DoD federal S-band (2025-2110 MHz) systems with non-federal/commercial users.

Our area of responsible is focused on coordinating DoD federal earth stations (satellite uplinks). We have been working with NAB/SBE and ENG representatives at the local and national level to begin the process of outlining mutually acceptable sharing criteria.
