- (1) Assignment in frequency bands 960-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) The station identification requirements of Section 5.152 of the Commission's Rules are waived.
- (3) The PRR used by the AN/APX-113(V) shall be an average of 375 interrogations per second. The pulse (interrogation) repetition interval (PRI) for the AN/APX-113(V) will be between 2400 and 2930 microseconds.
- (4) The interrogation modes of the AN/APX-113(V) are limited to Modes 1, 2, 3A and 3C. No Mode 4 interrogations are authorized.

Special Conditions:

- (5) The AN/APX-113(V) antenna (at 405200N/0732210W) shall be oriented towards the KT-76A (1090 MHz parrot) transmitter (at 405154N/0732436W) also authorized on this license.
- (6) The Mode 3A code for the KT-76A shall be 5117 and the Mode 3C response shall be 600 feet below ground level or above 60,000 feet AMSL.
- (7) The KT-76A antenna (at 405154N/0732436W) shall be oriented towards the AN/APX-113(V) transmitter (at 405200N/0732210W) also authorized on this license.
- (8) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by USAF Contract F33657-90-C-2233. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
