Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) POINT OF COMMUNICATION: INMARSAT 4F2 Satellite.
- (3) Hughes Network Systems, sub LLC shall assure that adequate guard bands are provided between the band edges of its carriers and the band edges of MSV's operations in order to preclude the possibility of unacceptable interference to MSV's operations.

Special Conditions:

- (4) Neither the aggregate uplink EIRP densities in the direction of any other L-band satellite serving the United States, nor the downlink EIRP densities at any geographical point within the United States, shall be increased as a result of the addition of experimental BGAN operations on the Inmarsat 4F2 satellite over those densities previously authorized on the Inmarsat 3F4 satellite.
- (5) Hughes Network Systems, sub LLC shall notify MSV prior to commencing operations and identify its point of contact.
