Special Conditions:

- (1) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (2) Operation is subject to prior coordination with affected Educational Broadband Service/Broadband Radio Service (EBS/BRS) licensees.
- (3) Licensee is required to coordinate operations with existing microwave users in the area to avoid interference.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (7) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at https://www.sbe.org/sections/freq_local.php to find the appropriate coordinator.
- (8) Insitu must notch out the following (+/- 9.25 MHz); 1790 MHz, 1815 MHz, 1840 MHz at the Boardman, OR location.
- (9) Insitu must ensure that operations occur within either restricted airspace or a COA.

Special Conditions:

- (10) Stop buzzer for this operation is Insitu the Operations Action Center at 866-637-4691.
- (11) The authorized station herein must not be used for air traffic control communications.
- (12) Prior to commencing any operations, the licensee must obtain consent from the following within 127 miles of the contours of the testing area:
 - SMR licensees (896-901 MHz/935-940 MHz)
 - B/ILT licensees (896-901 MHz/935-940 MHz)
 - Narrowband PCS licensees (901-902/930-931/940-941 MHz)
 - Location & Monitoring Service licensees (902-928 MHz)
 - Paging Service licensees in 929 MHz and 931 MHz
 - Broadband PCS licensees (1850-1910 MHz/1930-1990 MHz)
 - WCS (2305-2320 MHz/2345-2360 MHz) licensee (AT&T)
- (13) Aeronautical mobile operations in 2305-2310 MHz is not permitted (per Table of Frequency Allocations in rule Section 2.106 which specifically precludes the use of 2305-2310 MHz for aeronautical mobile)
