- (5) All operations subject to coordination with the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d) prior to operation in 2390-2489 MHz.

- (7) Transmission may not exceed AGL 5000 ft.
- (8) Operations on 1370-1381 MHz will be in accordance with the following restriction: Pulse Repetition Rate = 001 pps
- (9) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number N00019-12-D-0011. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
