Special Conditions:

- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) Operation must be consented to by ALL PCS licensees (1850-1910 MHz / 1930-1990 MHz) within 50 miles of the ground testing locations, and within 200 miles of the airborne testing locations.
