Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
- (5) The test equipment shall only be used indoors and shall be under the control of Insitu.
- (6) Insitu shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (7) GPS users in the area of potential interference to GPS reception must be notified that GPS information may be impacted for periods of time.
- (8) The designated point-of-contact to terminate transmissions if interference occurs is BEN SCHREFFLER at (509) 493-6690.
- (9) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number(s): N00019-09-C-0005, and N68335-10-C-0054. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
