Special Conditions:

- (1) Operation is subject to prior coordination with affected Educational Broadband Service/Broadband Radio Service (EBS/BRS) licensees.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (5) Insitu must not operate in the 5850 - 5875 MHz band. The Dedicated Short-Range communications (DSRC) technology has a co-primary allocation in this band and is used for collision avoidance in surface transportation.
- (6) Secure consents from the Advance Wireless Service licensees prior to accessing to 1710-1785 MHz, and 2110-2170 MHz, bands.
- (7) Coordinate with the incumbent fixed microwave in the 925.2-959.8 MHz, 927.4-957.6 MHz, and 2450-2462 MHz bands in each corresponding proposed venue prior to commence operation.
- (8) Operation is subject to obtain consent from the following within 50 miles of the contours of the testing area:
 - Cellular licensees (824-849 MHz/869-894 MHz)
 - SMR licensees (896-901 MHz/935-940 MHz)
 - B/ILT licensees (896-901 MHz/935-940 MHz)
 - Narrowband PCS licensees (901-902/930-931/940-941 MHz)
 - Location & Monitoring Service licensees (902-928 MHz)
 - Paging Service licensees in 929 MHz and 931 MHz
