- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (5) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (6) Station authorized herein must not be used to provide air traffic control communications
- (7) Aircraft operations are limited to U.S.-registered aircraft.
- (8) During transmission, aircraft shall not exceed altitude 4,000 feet.
During transmission in Pendleton OR, aircraft shall not exceed altitude 15,000 feet.
