Special Conditions:

- (1) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at http://freq.sbe.org/pdf_files/coordinators.pdf to find the appropriate coordinator.
- (2) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Operation in the frequency bands 925-960 MHz and 2390-2483 MHz must be prior coordinated Fixed Microwave licensees.
- (6) Operation in the frequency bands 925-960 MHz and 2390-2483 MHz must be prior coordinated with local SBE frequency coordinator.

Special Conditions:

- (7) Operation is subject to consent of the following within 50 miles of the test area:
 - * SMR licensees (896-901 MHz/935-940 MHz)
 - * All WCS licensees (2305-2320 MHz/2345-2360 MHz)
 - * All Broadband PCS licensee (1850-1910 MHz/1930-1990 MHz)
- (8) Stop buzzer point of contact for this operation is the Operations Action Center at 866-637-4691.
- (9) Operations in the bands 2305-2320 MHz and 2345-2360 MHz must comply with the emission limits applicable to those bands. See 47 C.F.R. § 27.53(a).
- (10) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
- (11) Obtain consents from the Broadband Radio Service licensees prior to operation in 2390-2483 MHz band.
- (12) Insitu must ensure the C2 operations are confined to the restricted air space in the Boardman Range.
