- (2) No WiMax equipment in the band 3300-3650 MHz will be offered for US sales.
- (3) No equipment shall be developed in this band since it is a federal government band for radiolocation. Any development needs to be done in an approved FCC band. WiMax should not be developed in the band 3300-3650 MHz for US sales.
- (4) Intel needs to be aware of possible interference from high power government radars in the band 3300-3650 MHz.
- (5) This license is for equipment that is intended for export only.
