- (4) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (5) Intel Corporation must coordinate its operations in 3550-3600 MHz band with one or more authorized Spectrum Access System (SAS) administrators to obtain channel assignments and avoid causing harmful interference to authorized users of the band, including General Authorized Access (GAA) users.
