This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Special Conditions:

- (1) No WiMAX equipment in the band 3300-3650 MHz will be offered for U.S. sales.
- (2) No equipment shall be developed in this band for use in the U.S. since it is a federal government band for radiolocation. Any development for use in the U.S. needs to be done in an approved FCC band. WiMAX should not be developed in the band 3300-3650 MHz for U.S. sales.
- (3) Intel Corporation needs to be aware of possible interference from high power government radars in the band 3300-3650 MHz.
- (4) This STA is for equipment that is intended for export only.
- (5) During the period September 4, 2006 thru September 20, 2006 the WiMAX will be operated intermittently for set up and testing. From September 20 thru September 30, 2006 continuous operations as need is approved.
