- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (5) Operation is subject to notification of the following incumbent licensees within 50 miles of the test area:
 - * Paging Service licensees in 454 MHz/459 MHz
 - * General Aviation Air-Ground Service in 454 MHz/459 MHz
- (6) Operation must be prior coordinated with NASA at Phone No. (757) 286-7297.
- (7) Operation is subject to notification of the incumbent licensees within 50 miles of the test areas:
 - * Location & Monitoring Service licensees (902-928 MHz)
